## ABOUT OUR PRIVACY POLICY

This privacy policy explains how Accuity Asset Verification Services ("AVS"), Inc., a RELX Group business, will use the personal information that is collected when you use our Service. This policy may be supplemented by additional privacy terms or notices set forth on certain areas of the Service.

### **INFORMATION WE COLLECT**

When you use the Service, AVS collects information from you in two ways: directly from your input and automatically from your use.

#### **Information You Input**

The types of personal information that the Service collects directly from you depends on how you interact with the Service and may include:

- Contact details, such as your name, email address, postal address and phone number; and
- Usernames and passwords.

#### Information collected automatically

The Service also automatically collects, through its servers and the use of cookies and similar technologies, certain information that tells us how you use the Service and may include:

- Internet Protocol ("IP") address used to connect your computer to the Internet;
- Computer, device and connection information, such as browser type and version, operating system, mobile platform, unique device identifier ("UDID") and other technical identifiers;
- Uniform Resource Locator ("URL") click stream data, including date and time stamp, referring and exit URLs, search terms you used and pages you visited or searched for on the Service; and
- For location-aware services, the region, city or town where your device is located in order to provide you with more relevant content for where you are in the world.

### **Cookies or similar technologies**

• Cookies are small text files that are placed on your computer or other device by websites that you visit. They are widely used in order to make websites work, or work more efficiently, store preferences as well as to provide information to the owners of the site.

- The Service requires cookies and similar technologies in order to operate fully. We and our advertisers also use cookies and similar technologies to serve and offer relevant adverts.
- You can manage cookies through your browser's settings and other tools. However, if you refuse certain cookies, some features of the Service may not function properly.

## **USE OF YOUR INFORMATION**

We use your personal information to:

Any use of your personal information for a purpose other than those described in this privacy policy will require your consent.

We also may disclose your personal information:

- to respond to or comply with any law, regulation, subpoena, court order or other legal obligation;
- to enforce and protect our rights and properties;
- to detect, investigate and help prevent security threats, fraud or other malicious activity; and
- to protect the rights, property or safety of our users, employees or others.

# ACCESSING AND UPDATING YOUR INFORMATION

The Service may allow registered users to directly access their account information and make corrections or updates upon login at any time. The accuracy of such information is solely the responsibility of the user.

You may also request access to other personal information about you that you have provided to us through the Service and have any inaccuracies corrected by contacting us, subject to applicable law. To protect your privacy and security, we may require you to verify your identity.
